KEY QUALIFICATION

Dr. József Hegedüs has more than 20 years of experience in **municipal finance and local government issues**. He has been working on projects related to decentralization in transition countries in the East-Central European region. He was working with a group of local experts to develop the new law on the city of Skopje with special emphasis on intergovernmental relations. In Ethiopia, Dr. Hegedüs worked with the regional governments of Tigray and Amhara on the reform of the intergovernmental transfer system in order to give more autonomy to local governments. Dr. Hegedüs led an expert group to design a formula based local government housing sector grant in Hungary, which is still in use. At a two-week post-graduate summer course held every year since 1999 at the Central European University Budapest, Hegedüs has been sharing recent knowledge on decentralization with practitioners and students from the region. He worked as a regional coordinator in a World Bank project to evaluate the possible use of statistics in intergovernmental relations in Bulgaria, Slovenia, Slovakia and Romania. He has been working with local governments to improve their financial management (budgeting, etc.) in Hungary and abroad (Russia). He has 10 years of teaching experience in a post-doctoral course offered at the Eötvös Lorand University Budapest on financial management of social institutions of local governments. He worked with the city of Tatabánya in the 'Cities for Change' project helping to build up background research support for Local Economic Development. He organized a special study tour on local economic development in Hungary for a group of experts from Kosovo, and designed a three-day course on Local Economic Development in Albania. Dr. Hegedüs studied several issues related to intergovernmental fiscal relations in the region: he led a team working on the role of non-tax local government revenues, was a co-author of a chapter on municipal borrowing in

Hungary, and has recently conducted research on local governments' contingent liability in Hungary.

Dr. József Hegedüs has also more than 20 years of experience in working **on housing issues in Hungary and countries in transition**. Within Hungary he has been a member of the National Housing Policy Committee (advisory group for the government) since 1996 and co-author of several housing policy papers commissioned by the Hungarian government. He was the author and team leader of projects aimed at developing local housing strategies for various cities in Hungary (Budapest, Nyíregyháza, Tiszaújváros, Tiszafüred and some district municipalities of Budapest). Internationally he has also been active in research and policy advising. In the mid-nineties he was one of the main researchers of the regional housing indicator project of UN Habitat and the World Bank. He was working on housing policy issues in South-East European projects directed by the Council of Europe and the Council of Europe Development Bank from 2000 till 2004. He has been the consultant of a Council of Europe project on housing for vulnerable people, which involved Bulgaria, Russia, Croatia, Romania and the Czech Republic. In 2008 he has been working in an EU project helping the government of Bosnia-Herzegovina to develop a social housing strategy. J. Hegedüs was one of the organizer of the workshop held in Budapest on social housing in Eastern Europe. Since 1989 he has been one of the working group coordinators of ENHR (European Network of Housing Researchers) on Eastern European Housing Policy. He was a member of the advisory board of the Habitat for Humanity housing policy index project.

Dr Hegedüs is a founding member of Metropolitan Research Institute, which was established in 1989. Dr. Hegedüs carries out research in housing policy, urban economics and municipal finance. He has worked in several technical assistance projects in transitional countries (Albania, Bosnia-Herzegovina, Georgia, Bulgaria, Russia, Macedonia, Serbia) financed by USAID, Council of Europe, Council of European Development Bank, the World Bank, World Bank Institute, Bertelsman Foundation, UNDP and the Open Society Institute. He was member of the Advisory Board of the Global Research Network on Human Settlements (HS-NET) between 2004-2009.
