Outline

After the political turn in the socialist countries in East and Central European Region, the state had to “withdraw” from the housing sector: cutting the subsidies for the new construction (both public and private), privatization of the building industry and industry for building materials, price liberalization in housing services, privatization of the public housing, privatization of the banking sector etc. In the process of transition, negative consequences of economic restructuring (regional and social inequality, declining living standards, affordability problems, etc.) have raised the need for social housing. Governments in the region started programs after the recovering from the transitional recession and started social housing programs in the beginning of this decade, some more some with less success.

The workshop aims to gather the present and future stakeholders of the emerging new housing systems to exchange recent experiences (failures and successes). On the one hand, *researchers* from the former socialist states and the European area will summarize their findings on the reshaping of housing systems of the region, on the other hand *policy makers* and *practitioners* will discuss the conditions, contexts and outcomes of social housing programs. In this framework, the workshop will also provide for an occasion of disseminating the results of the recent activities of the Council of Europe’s expert group on housing related issues of social cohesion (CS-HO) including the guidelines for housing policies for vulnerable groups.

Bringing together the analytical *and* the practical approach will allow for a better understanding for the success stories and failures of the diverse experiences related to social housing programs and the ways of constituting social housing policies in the region.
